The Board of County Commissioners of Butler County, Ohio met in Regular Meeting on the 17th day of October, 2022 in the Commission Chambers of the Butler County Government Services Center, 315 High Street, 2nd Floor, Hamilton, Ohio 45011.

Whereas the Board of County Commissioners, pursuant to ORC 325.19(D)(1), is required to provide holiday pay to full time county employees;

Whereas the 134th General Assembly enacted Amended House Bill 110, effective September 30, 2021 determining the legal holidays for employees;

Whereas by authority of ORC 325.19(F), the Board does hereby adopt the following alternative schedule of legal holidays for Butler County during the year 2023, which the schedule is not inconsistent with the provisions of collective bargaining agreements governing bargaining-unit employees of Butler County:

Now, therefore, be it

Resolved that all County Buildings shall be closed on the dates listed above with the exception of those which must remain in operation including the County Care Facility, County Jail Facilities, and the County Juvenile Detention Facilities; be it further

Resolved that the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its committees, which resulted in those formal actions, were in meetings open to the public in compliance with the law.
