Sealed bids will be received at the office of the Board of County Commissioners of Butler County, Ohio on the 6th Floor of the Butler County Government Services Center, 315 High Street, Hamilton, Ohio until **10:30 a.m.** local time on **Tuesday, MARCH 13, 2018**, and will be opened and read aloud at 10:45 a.m. or shortly thereafter in the Commissioners' Conference Room on the 6th Floor. **The Contract involves furnishing all labor and materials required to install 1,150 feet of 12" ductile iron water main and appurtenances.**

Each bid must contain the full name and street address of the bidder, a signed Non-Collusion Affidavit, a signed Personal Property Tax Affidavit, and a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code. Bids shall be sealed and shall be clearly marked on the outside of the package "BIDS FOR **STADIUM CONNECTOR-WATER MAIN EXTENSION** FOR THE WATER AND SEWER DEPARTMENT." Failure to submit bid proposals in conformance with the Contract Documents will result in rejection of the bid as non-responsive.

Bidders must comply with the prevailing wage rates on Public Improvements in Butler County, Ohio as determined by the Ohio Bureau of Employment Services, Wage & Hour Division.

Engineer's estimate for the base bid is \$185,000.00.

The right is reserved by the County to reject any or all Bids, to waive formalities, to accept the lowest and best Bid, and to hold Bids for a period of sixty (60) days after the bid opening for evaluating both the Bids and Bidders.
